

GUIDELINE FOR APPEARING IN MUHS EXAMINATION.

(For undergraduate and postgraduate students)

- 1) Students should strictly adhere to the COVID-19 advisory, issued by the Government authorities.
- 2) For travelling they should carry a copy of MUHS examination circular and institute ID card.
- 3) If any relative or parents are coming for dropping student, they have to drop the student on the main gate and they have to go back from there only. No relatives or parents are allowed to stay with students.
- 4) Whenever students come to campus he/she will report first to medicine OPD (Casualty after 5:00 pm) and after getting certified from medicine OPD he/she will be asked to be quarantined for 14 days.
- 5) As in hostel, students will not be allowed to come out from hostel even for food. They need to carry their own essential things like two Tiffin, boxes, bucket, mug, soap glasses and daily requirement things. Breakfast, lunch, tea, dinner will be given by hostel mess at their rooms only.
- 6) As per discussion, the room allotment will be as per alphabetical order. No choices will be given for choosing room partners.
- 7) Don't gather or make rush in the areas of washrooms and bathrooms.
- 8) Try to remain in the room; avoid unnecessary contacts by roaming in the campus, mess and library without any reason.
- 9) You will not be allowed to leave the campus for any reason.
- 10) Inform suspicious symptoms immediately to the hostel warden
- 11) Students coming from outside Nagpur can stay in hostel by paying minimum rent decided by the hostel committee. Students in need of accommodation should inform in the college prior to their arrival.
- 12) All the residents who are availing paying guest facility / rent outside campus are to be quarantined at their paying guest accommodation / rented residence for 14 days and after obtaining fitness certificate from medicine dept they will be allowed to appear for exam.
- 13) Hostel wardens will be keeping record of entry and exit of students and students have to follow orders strictly otherwise disciplinary action will be taken.
- 14) Local Students residing at their homes will have to show the valid address proof of their residence.
- 15) If they are residing in contentment zone they have to stay in campus hostel for the exam period. They should report to hostel 14 days before exams.

- 17) Students coming from outside of Nagpur should reach Nagpur at least 14 days before exam.
- 18) Students using public transport like bus, planes, and trains have to show their proof of travel after reaching Nagpur.
- 19) Library will be available for studying but social distancing, avoidance of gathering and wearing of masks is compulsory.
- 20) Library will be sanitized periodically but it is advisable to disinfect the area (e.g. table, chair, glass etc.) where you are seating before you seat
- 21) Don't make any crowd while entering in to examination hall. Keep social distancing protocol.
- 22) Don't bring any belonging while coming for examination only pen, pencil, hall ticket & Identity card will be allowed.
- 23) Please note that you are under CCTV surveillance constantly.
- 24) Students will be asked to sign a consent form before appearing for exam.
- 25) In case of any medical issue immediately contact hostel warden so that immediate medical support will be provided.
- 26) Don't hide your symptoms it may be harmful for you and others.
